POLITICS OF THE EUROPEAN UNION

Course Description: This course will examine the history, institutions, and contemporary politics of the European Union (EU). It will start by providing students the normative and strategic foundations for the creation of the EU's predecessor organizations. It will then explore the EU's institutions such as the Commission, Parliament, and Court of Justice and their interactions with one another. Students will also explore the politics of the Euro and the consequences of a unified monetary policy. Furthermore, students will learn about the intertwined relationship between national governments and the EU. The course will additionally provide context for emerging euroskepticism and the political dynamics behind Brexit and other anti-EU movements. Lastly, the course will finish by tackling contemporary issues of democratic backsliding in Europe and challenge students to think about whether the EU is a suitable organization to protect liberal democracy

Objectives: Students will become knowledgeable in the major themes within the academic literature on the politics of the European Union. By engaging with contemporary events, students will be able to apply what they learn in class to the real-world outcomes. Other objectives include:

- To provide students with the conceptual and theoretical foundations to understand the design of the EU
- To empower students to apply these contexts in both contemporary and historical topics
- To develop students analytical and research skills through critical reading and written application assignments

Course Format: This course will be primarily lecture-based. Students are expected to have completed the assigned readings in preparation for lecture.

Grading Policy:

1. Participation (20%): Students are expected to actively participate in class each week. Students will have the option of commenting on the readings or opting into cold-calling.

- Commentary: Each student is required to select four class sessions during the semester in which they will write a paragraph and submit at least two discussion questions on blackboard based on the readings for that class. Each commentary is worth 25% of the participation grade. A google document will be circulated after the second class session for students to sign up for the sessions in which they will submit their discussion questions. Students must submit their commentary by 8 am the day of class. Students who choose this option will not be cold called.
- Cold Calling: Students will be called on at random during class sessions to answer questions or provide their thoughts on the topic at hand. If a student is cold called and they are not present in class for the session they will lose 10% of their participation grade. Students who choose this option do not have to provide commentary on the readings for four different sessions.
- 2. Exams (40%): Students will take two non-cumulative exams during the semester. The exams will be on elearning.
- 3. Final Paper or Final Exam (40%): Students will have the option to complete a final paper assignment for the class will be due on the final class session or take a final exam. The paper will 8 10 pages in length, double space, 1 inch margin, and 12pt font not including the bibliography. Students are encouraged to ask any questions regarding this final assignment in office hours. Alternatively students can take a cumulative final exam on the last day of class.
- 4. **Final Exam Exemption:** Students will be exempt from the final exam if they fulfill the following criteria:
 - They have an average of an A grade in the class following Exam 2
 - They have a participation grade of 90% or higher following Exam 2:
 - Students who sign up for reading commentaries must submit all four reading commentaries by Exam 2
 - Students who sign up for cold calling are only allowed to have been absent from class once when cold called
 - They submit four additional reading commentaries between Exam 2 and the Final Exam **OR** they sign up for cold calling and are not absent when cold called
